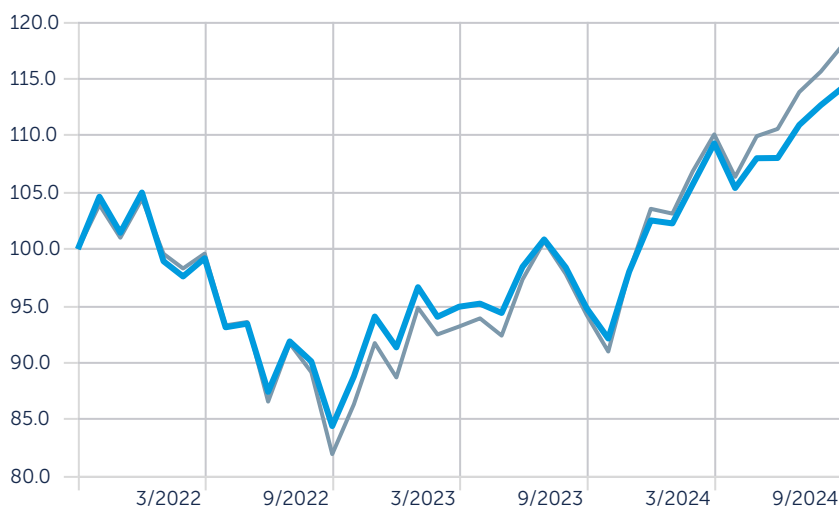

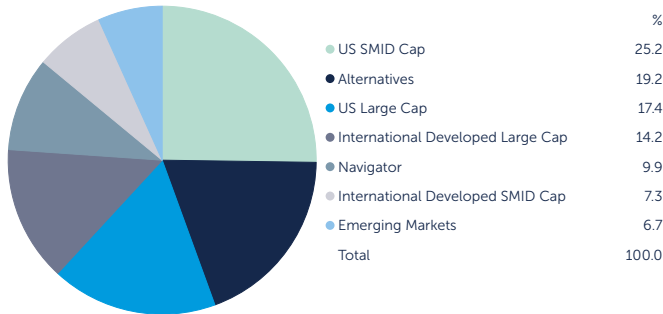

From model inception to October 1st, 2023, OneAscent Investment Solutions used 25bps as the amount of fees to be imputed to arrive at a net performance number. All net performance calculations as of October 2nd, 2023, will use a 35bps fee amount which OASIS believes is a better estimate of the highest potential expense for an investor in this strategy.

Performance information for the attached strategy is calculated using model performance and is based on the portfolio allocation data since inception. The strategy has not materially changed since inception. Model performance is net of any fees on the underlying mutual funds and ETFs, management fees of any underlying model portfolios, and a strategist fee of 0.25% applied annually to the entire strategy. The model performance does not include any overlay fees, brokerage fees, or commissions. OneAscent is unaware of what the exact amounts of these fees will be on a client by client basis, and cannot reasonably estimate their costs. Performance for periods longer than a year has been annualized.
