

As of September 2022, the OneAscent Peak w/ Alts Conservative Builder and OneAscent Peak w/ Alts Conservative Core models were combined, with the current OneAscent Peak w/ Alts Conservative Core model being the surviving combination of the two. The historical (pre September 2022) performance of this model includes the past performance of the OneAscent Peak w/ Alts Conservative Builder model, as this model is the model that most closely resembles the current OneAscent Peak w/ Alts Conservative Core model.


From model inception to October 1st, 2023, OneAscent Investment Solutions used 25bps as the amount of fees to be imputed to arrive at a net performance number. All net performance calculations as of October 2nd, 2023, will use a 35bps fee amount which OAIS believes is a better estimate of the highest potential expense for an investor in this strategy.

Performance information for the attached strategy is calculated using model performance and is based on the portfolio allocation data since inception. The strategy has not materially changed since inception. Model performance is net of any fees on the underlying mutual funds and ETFs, management fees of any underlying model portfolios, and a strategist fee of 0.25% applied annually to the entire strategy. The model performance does not include any overlay fees, brokerage fees, or commissions. OneAscent is unaware of what the exact amounts of these fees will be on a client by client basis, and cannot reasonably estimate their costs. Performance for periods longer than a year has been annualized. Model performance means that while actual client accounts will be managed as closely to the model as possible, the performance reported is for the targeted portfolio allocations for the strategy and not a composite of actual client accounts. Accordingly, individual client performance may vary according to various factors, including fee arrangements, withdrawals, contributions, and tax considerations, among other factors. The benchmark used for this strategy is a blend of five broad based market indices and benchmark performance is calculated by Morningstar. Blended benchmarks are rebalanced back to their target weights each calendar year. The five broad market indices are S&P 500, Russell 2500, MSCI ACWI ex USA, Bloomberg Barclays US Aggregate Bond, and the Wilshire Liquid Alternative. The S&P 500 is a market cap-weighted index of the 500 largest U.S. publicly traded companies. The Russell 2500 is a market cap-weighted index that includes the smallest 2,500 companies covered in the Russell 3000 universe of U.S. companies. The MSCI ACWI ex USA (Morgan Stanley Capital International All Country World Index Ex-U.S.) is a market-cap weighted index designed to provide a broad measure of stock performance throughout the world, with the exception of U.S.-based companies. The Bloomberg Barclays US Aggregate Bond is an index designed to provide a broad measure of the U.S. bond market and includes government securities, mortgage-backed securities (MBS), asset-backed securities (ABS), and corporate securities. The Wilshire Liquid Alternative Index aims to deliver a precise, broad market measure for the performance of diversified liquid alternative investment strategies that are implemented in mutual fund structures.
